

# Atrazine products which include and which do not include "terraced field" standpipe setback language on their labels

Minnesota Department of Agriculture, 1-7-09

Atrazine products differ in the label language they use to describe application setback requirements for tile-outletted fields with standpipes. Approximately 70% of atrazine products reference "terraced fields" on their labels and 30% do not.

When "terraced fields" are referenced on the label, then the application restrictions only apply to standpipes in fields which are terraced. If "terraced fields" is not referenced, then the application restrictions apply to all standpipes, whether they are in fields which are terraced or not.

The Minnesota Department of Agriculture (MDA) interprets references to "standpipes" on atrazine labels to include all surface tile inlets, including open inlets, slotted riser pipes, and rock inlets.

Examples of label language which reference and do not reference "terraced fields" are given below:

#### A) Tile-Outletted Terraced Fields Containing Standpipes (70% of labels use this language)

One of the following restrictions must be used in applying atrazine to tile-<u>terraced</u> fields containing standpipes:

- 1. Do not apply this product within 66 feet of standpipes in tile-outletted terraced fields.
- 2. Apply this product to the entire tile-outletted <u>terraced</u> field and immediately incorporate it to a depth of 2-3 inches in the entire field.
- 3. Apply this product to the entire tile-outletted <u>terraced</u> field under a no-till practice only when a high crop residue management practice is practiced. High crop residue management is described as a crop management practice where little or no crop residue is removed from the field during and after crop harvest.

#### B) Tile-Outletted Fields Containing Standpipes (30% of labels use this language)

One of the following restrictions must be used in applying this product to tile-outletted fields containing standpipes:

- 1. Do not apply this product within 66 feet of standpipes in tile-outletted fields.
- 2. Apply this product to the entire tile-outletted field and immediately incorporate it to a depth of 2-3 inches in the entire tile-outletted field.
- 3. Apply this product to the entire tile-outletted field under a no-till practice only when high crop residue management practices are used. High crop residue management is described as a crop management practice where little or no crop residue is removed from the field during or after crop harvest.

Voluntary Water Quality Best Management Practices (BMPs) developed by the Minnesota Department of Agriculture for atrazine recommends that application setbacks and vegetated buffers be adopted around all surface tile inlets, whether they are in fields which are terraced or not.
