Dear License/ Registrant:

The Agricultural Chemical Response and Reimbursement Account (ACRRA) awards funds for eligible costs to clean up agricultural chemical spills and incidents. Since 1990, this environmental protection program has reimbursed more than \$60 million for site cleanup in Minnesota. The program is funded by surcharges on pesticide and fertilizer licenses, pesticide registrations, pesticide sales and fertilizer tonnages.

The ACRRA Law (Minn. Stat. Chapter 18E.03, Subd. 3) authorizes the Commissioner of Agriculture to maintain a fund balance within the limits identified in the statute. ACRRA surcharges were decreased in January of 2024 from levels that had been set the previous year due to the account approaching the statutory maximum allowed. The balance is still projected to surpass the maximum balance of 6.5 million dollars based on the estimated expenditures and revenue trends unless surcharge rates decrease once again.

A public hearing was held on Wednesday, August 21, 2024 to discuss decreasing surcharge rates. Following that hearing, the Commissioner of Agriculture determined that an adjustment to the surcharges is necessary at this time in order to continue to keep the fund balance within limits and to maintain this valuable program that protects Minnesota's environment. All surcharges will change with the new surcharge adjustments.

The ACRRA surcharge rate will decrease on January 1, 2025. The change will be reflected on forms and reports distributed by the MDA. The following is a brief summary of ACRRA surcharge changes:

1. Commercial and Noncommercial Pesticide Applicator Licenses will pay a surcharge of \$21 (previously \$25) per license and Structural Pest Control Company will pay \$85 (previously \$100) per license. Contact [pesticide.licensing@state.mn.us](mailto:pesticide.licensing@state.mn.us), 651/201-6615.
2. Pesticide Dealers will pay a surcharge of 0.27% (previously 0.32%) on sales of agricultural pesticides sold in Minnesota during the period of January 1 through December 31, 2025. Contact Jessie Rahmeyer, [jessie.rahmeyer@state.mn.us](mailto:jessie.rahmeyer@state.mn.us), 651/201-6188.
3. Pesticide Dealers will pay a surcharge of \$64 (previously \$75) per license. Contact Jessie Rahmeyer, [jessie.rahmeyer@state.mn.us](mailto:jessie.rahmeyer@state.mn.us), 651/201-6188.
4. Fertilizer companies will pay a surcharge of \$42 (previously \$50) per license. Contact Lorinda Balfanz, [lorinda.balfanz@state.mn.us](mailto:lorinda.balfanz@state.mn.us), 651/201-6092.

Fertilizer and soil/plant amendments distributors will pay a surcharge of \$0.27 per ton on sales (previously \$0.32) for products sold in or into Minnesota during the period beginning January 1, 2025. 6. Pesticide registrants will pay a surcharge of 0.27% of sales (previously 0.32%) for each non-agricultural pesticide product registered for sale and use in Minnesota during the period of January 1 through December 31, 2025.
