Steps to report and upload dealer sales

1. Compile sales data for each agricultural pesticide product sold in the year

Include the following information:

- Minnesota Department of Agriculture (MDA) Product Number
- EPA Registration Number
- Amount Sold, and
- Sales Dollars.

2. Sales data must be saved as a CSV file. If not, the data will not upload correctly. There are two (*.csv) options when saving a file, be sure to select "CSV (Comma delimited)". See image below.



3. Report dealer sales using the online Pesticide Sales Report

Use the link above or navigate from the MDA's home page (www.mda.state.mn.us)

Click on: "LICENSING & INSPECTIONS" Under: "FILE A REPORT" Click on: "PESTICIDE SALES REPORTING".

Once on the page:

- 1. Enter your License Number and PIN
- 2. Select "Create Sales Report" or "View Completed Sales Report"
- 3. Click "Login"
